

Participation Agreement

I understand and agree, on behalf of all releasing parties as follows,

1. **Releasing parties** - Include: The participant(s) named above and their family members, guardians, heirs, next of kin and anyone else who might claim or sue on the participation(s) behalf or for injury to the participant(s), including any representatives, successors and assigns, or insurers.

Released Parties include Kernow Slide Ltd, employees, directors, owners, contractors, subcontractors, insurers, spectators, equipment suppliers, volunteers, subsidiary or affiliated companies.

2. **Acknowledgement of risk** - I understand that there are risks associated with participation and use of Kernow Slide LTD slip and slide and items on the event site within the common areas. In particular multiple sliders using the slide at the same time with or without equipment can substantially increase risk of injury. All surfaces may be uneven and slippery especially when wet, the ground (where covered or uncovered), slide surface, steps.

All participants agree to read and follow all posted signs and verbal instruction of the slide staff at all times while in the event premises/area and fully understand the slide safety information in all formats.

I know the nature of the slip and slide activity and I understand that not all risks can be eliminated.

3. **Potential injuries and medical conditions** - All participants must be confident within water. The risks of participating in the slide / event activities are extensive / significant and may cause minor, serious and catastrophic injury to a person or damage to property.

These could include but are not limited to: Head injury, sprains, strains, burns, cuts, bruises, drowning or near drowning. Accidents and / or injury involving but not limited to falling, slipping, sliding, running, travelling / movement with or without equipment. Catastrophic injuries can include but are not limited to the following: permanent disabilities, spinal injuries, heart attack, stroke and even death.

I understand that by participating, I will be slipping and sliding within chlorinated water and potential mud and other substances, which may not be tested for or treated for disease or illness. I understand that Kernow Slide Ltd or its employees and directors cannot be held responsible or liable for any person visiting our premises / site, participants or spectators or anyone using our equipment for the

contraction or transmission or any disease or illness.

I understand the types of injury that might result from engaging in the slip and slide activity. I understand the demands relative to my physical condition. It is my responsibility to consult with my doctor before participating in the slip and slide event to ensure that my participation will not pose any unusual risks to my health or well-being. I do not have any conditions that would be made worse by participating in the slip and slide event. Any medical treatment resulting from my participation shall be at my own expense.

4. **Assumptions or risks and indemnification agreement** - I Assume all the risks of participating and I take full responsibility for any and all damages, liabilities, losses or expenses that I may incur as a result of participating, both known and unknown. I voluntarily and forever waive, release, covenant not to sue Kernow Slide Ltd and discharge the released parties from any and all claims resulting, in whole or in part, from the risks of participating in the slip and slide activities or from the ordinary negligence or any of the released parties.

I agree to hold harmless, defend and indemnify the released parties from and against any and all claims made by me, any co participants, rescuers and others, arising from injury or loss due to my participation in this activity.

5. **Severability and integration** - If any part of this document is found to be unenforceable, then the provision is severed from the agreement and does not affect the validity of any remaining parts
6. **Cancellation** - If the activity is cancelled, postponed or modified due to weather conditions, acts of god, or other factors beyond the control of any releasee. If we cancel the activity we will contact you by email and post on social media, we will offer you the chance to rebook or have a full refund. Kernow Slide Ltd wont be liable for any loss or inconvenience caused.
7. **Dismissal** - I acknowledge and accept that I may be dismissed from participation, without refund, if I endanger the safety or negatively affect the event, a person, a facility or property of any type or kind.
8. **Photography and audio visual recording consent** - By signing this form, you consent to Kernow Slide Ltd, to take photographs and video recording of any of the participants names on this form or any spectators visiting our premises which may be used for general publicity, to be displayed and used on our website or our associated social media sites.
